TRADES SCHOLARSHIP CRITERIA ELIGIBILITY

- A. Completed and signed Application Form.
- B. Course description, including location.
- C. Extracurricular Activities listing (one page limit).

- E. Essay Questions (one page limit).

AWARDS

- A. Scholarships are not automatically renewed. Students will be considered for subsequent awards if they provide evidence of continued need, continued interest in construction, and continued enrollment and good standing in a construction-related field.
- B. Individuals are limited to receiving the scholarship award a maximum of (2) times.
- C. Applications will be reviewed, and winners selected by the PACTS Board of Directors in a double-blind review. They will consider applicant's interest in industry, extracurricular activities, and employment experience. All applicants will be notified of their status no later than June 30th.
- D. Checks will be sent directly to the school no later than August preceding the school year.
- E. The ESOP scholarship sponsors five (5) annual scholarships, valued at \$2.000.00 each.
